- 1. The offense for which extradition has been granted or a differently denominated offense based on the same facts on which extradition was granted, provided that such offense is extraditable, or is a lesser included offense;
- 2. An offense committed after the extradition of the person;
- 3. An offense for which the Republic of China (Taiwan) consents to the person's detention, prosecuted, trial, or punishment for an offense;

The requested person under this request may not be extradited to a third State for an offense committed prior to his/her surrender unless the Republic of China (Taiwan) consents.
