Don't slack off on epidemic prevention, but also don't stop the auction

The total highest-bidding amount made from the AEA joint auction held on the “first” “Tuesday” of every month, starting at “3” p.m. reaches around NTD 70,640,000.

The branches of AEA held the joint auction held on the “first” “Tuesday” of every month, starting at “3” p.m. in the afternoon of May 3, 2022, and provided various items in the auction for the public to bid. The total amount made from the highest-bidding of the joint auctions reached NTD 70,648,210, and all income thereof will be collected by the treasury.

The total amount made from the highest-bidding of the real property is NTD 66,860,485. The one with the highest-bidding are the 2 lands located at Zhongxing Section, Fuxing Township, Changhua County and auctioned by the Changhua Branch. The areas of the lands are 3,655 square meters, and the amount made from its highest-bidding is NTD 32,366,600. The one with the second highest-bidding amount is the land located at Jincun Section, North District, Taichung City. The amount made from its highest-bidding is NTD 9,100,000. Another building located on Jinshan Street, Yangmei District, Taoyuan City, adjacent to Yangmin Park and Yangmin Elementary School, near Yangmei Interchange and Yangmei Train Station, with convenient transportation, is auctioned by Taoyuan Branch for NTD 7,219,999. Three lands located at Shengli Section, Miaoli City, Miaoli County and auctioned by Hsinchu Branch for NTD 1,459,200; and two lands located at Meishan Section, Hsinchu City and auctioned by Hsinchu Branch for 397,000. In addition, three lands and one building located in Beitou, Taipei City are auctioned by Shilin Branch for NTD 1,450,001; two lands located at Liukuailiao Section, Anding District, Tainan City are auctioned by

Tainan Branch for NTD 1,200,000; and the land located at Pizitou Section, Baihe District, Tainan City is auctioned by Tainan Branch for NTD 540,000. 高 The land located at Dazhuang Section, Dashu District, Kaohsiung City, and the land located at Laonong Section, Liugui District, Kaohsiung City are auctioned by Kaohsiung for NTD 802,000 and NTD 236,888 respectively. Other branches also auctioned various real properties in good conditions and ended the conclusion of the auction with exceptional results.

The total amount made from the highest-bidding of the personal properties is NTD 3,787,725. The one with the highest-bidding is a Volkswagen sedan, which is auctioned for NTD 700,000; a KIA sedan which is auctioned for NTD 250,000; an Isuzu minivan which is auctioned for NTD 146,000, and a KYMCO motorcycle which is auctioned for NTD 32,000. In addition, there is also a LEXUS sedan, MITSUBISHI MOTORS sedan, Mazda sedan, and Kuozui sedan, all of which were sold at very affordable prices. The rest of the personal properties auctioned or sold include Tatung TV screens, EPSON WF-2831 copiers, cell phone accessories, restaurant trademark rights, original wood furniture, jade jewelry, floral ornaments, wallets for men, belts, Kinmen sorghum wine, toys, stocks and other items.

AEA reminds the public of the recent increase in the local epidemic of Covid-19, and advises the public to participate in real properties auctions by the method of communication bidding to reduce the risk of epidemic from entering auction venues.
